If the cancellation is made less than 30 days in advance, Subscriber will be charged on a prorated basis. No deposit will be returned without a prior written notice.**

LIMITS OF LIABILITIES: ALC will transmit and relay messages from and to Subscriber with best care possible, but takes no responsibility of their contents. ALC should not be held liable for any damage due to the causes of the phone company or unavoidable mechanical problems.

RELATIONSHIP OF PARTIES: Under no circumstance should ALC be considered an employee, agent, or servant to Subscriber. ALC reserves the right to refuse transmission of any messages which, in its sole and absolute judgment, contains obscene, libelous, illegal or otherwise offensive language or content.
